Clarification

- Candidate pack fees for some **first aid** qualifications include a manual and certificate. This is zero rated for Vat, thus there is no additional cost for non-Vat registered Centres.
- All other fees listed above attract Vat at the current rate, e.g. registration/certificate only for first aid qualifications and non-first aid qualifications.
- EQA service fee includes:
 - Centre approval (initial and on-going)
 - Assessor approval (initial and on-going)
 - Centre policy document approval (initial and on-going)
 - Centre reports (any aspect of function)
 - Planned Centre visits according to risk
 - Routine unplanned EQA visits as part of routine sampling
 - Bespoke ITC External Quality Assurer attached to your Centre, familiar with your Centre
 - Bespoke ITC Web-Office space training and guidance

4. EQA service fee does not include:
 - a) Additional EQA visits required as a result of a Centre's risk rating being increased, ie for maladministration, malpractice, extra training/standardisation requirements, etc
5. EQA sanction fee – if an unannounced EQA visit occurs and:
 - a) The course has been cancelled, but not cancelled on the ITC WebOffice
 - b) The course venue is not as shown on the ITC WebOffice
 - c) The course date or time has been changed, but ITC has not been notified
6. Centre bespoke training: £330 + VAT & Expenses (ie, travel, accommodation, etc)
7. Services not charged for:
 - a) Qualifications Registration Fees
 - b) Assessor Accreditation Fees
 - c) Course amendments on ITC WebOffice, ie change of venue, date, Assessor, etc.
